

RESOLUTION R- 12-2019
VILLAGE OF BOLIVAR

A RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE
TEN MILL LIMITATION AND DECLARING AN EMERGENCY
REV. CODE, SECS. 5705.19, .191, .192, .194, .21, .26

The Village Council of the Village of Bolivar, Tuscarawas County, Ohio, met in regular session on the 1st day of July, 2019, at the office of the Village Hall, with the following members present:

Member **Tim Lang** moved the adoption of the following Resolution:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Bolivar, Tuscarawas County, Ohio; therefore, be it

RESOLVED by the Village Council of the Village of Bolivar, Tuscarawas County, Ohio, two-third of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Bolivar, Ohio for the purpose of providing and maintaining police protection for the Village of Bolivar purposes pursuant to Ohio Revised Code Section 5705.19 (J) at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to \$0.15 for each one hundred dollars of valuation, for a renewal of an existing levy of 1.5 mills commencing in 2020 and first due in calendar year 2021. Said levy shall be a renewal of an existing levy, to be levied upon the entire territory of the Village of Bolivar, Ohio and shall be renewed for a period of five (5) years.

Pursuant to Ohio Revised Code ORC Section 5705.19(J)

RESOLVED, that the question of levying the renewal taxes be submitted to the electors of said Village of Bolivar at the general election to be held at the usual voting places within said Village of Bolivar on the 5th day of November, 2019; and be it further

RESOLVED, that said levy be placed upon the tax list of the current year after the February settlement next succeeding election, if a majority of the electors voting thereon vote in favor thereof; and be it further

RESOLVED, that the Fiscal Officer of this Bolivar Village Council be and is hereby directed to certify a copy of this Resolution to the Board of Elections, Tuscarawas County, Ohio not less than 90 days prior to the General election upon which it will be voted, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Member Megan Gettan seconded the Motion and the roll being called upon its adoption, the vote resulted as follows:
