

ORDINANCE # O-15-2022

AN ORDINANCE TO CHANGE THE EMPLOYMENT STATUS FOR PATTY SMITH FROM FISCAL OFFICER TO ASSISTANT FISCAL OFFICER FOR THE VILLAGE OF BOLIVAR; ESTABLISHING AN EMERGENCY

WHEREAS, Patty Smith had advised the Village Council of the Village of Bolivar, Ohio, that she wished to resign from her position as Fiscal Officer.

WHEREAS, the Village Council of the Village of Bolivar, Ohio, has hired Krystal Christensen as the Fiscal Officer pursuant to Ordinance O-13-2022 passed April 21, 2022;

WHEREAS, the Village Council of the Village of Bolivar, Ohio wishes to retain Patty Smith as an employee of the Village to assist Ms. Christensen to transition the duties and responsibilities of Fiscal Officer.

WHEREAS, Patty Smith has expressed an interest in taking the position of Assistant Fiscal Officer with the Village;

WHEREAS, the Village Council believes that Patty Smith is qualified for the position and wishes to hire Patty Smith as the Assistant Fiscal Officer for the Village;

WHEREAS, Patty Smith shall be paid a rate of \$1,000.00 per month in her capacity as Assistant Fiscal Officer, not to exceed twenty (20) hours a week through the months of May, June and July 2022;

WHEREAS, the Village shall continue to withhold taxes for Patty Smith and shall make contributions to Patty Smith's Ohio Public Employees Retirement System.

WHEREAS, Patty Smith will maintain health insurance coverage through the Village Health Insurance Plan through July 31, 2022 at 11:59 p.m., at which time she will agree to the Village terminating her medical coverage through the Plan.

NOW, THEREFORE, BE IT ORDAINED by the Village Council the Village of Bolivar, Ohio, as follows:

SECTION 1. The Village Council for the Village of Bolivar hereby approves the hiring of Patty Smith as Assistant Fiscal Officer under the aforementioned conditions effective May 1, 2022.

SECTION 2. This Ordinance is hereby declared to be an emergency measure and its passage is immediately necessary in order to preserve, protect, and

maintain health, safety and welfare of the citizens of the Village of Bolivar, Ohio, and to ensure adequate coverage for fiscal office duties for the Village in the event of emergencies and for the daily functioning of the Village, and therefore the same shall be in full force and effect immediately upon its passage and approval.
