

ORDINANCE 25-2022

**AN ORDINANCE DECLARING IT NECESSARY TO
REPLACE AND INCREASE A LEVY ON TAX IN
EXCESS OF THE TEN MILL LIMITATION
REV. CODE, SECS. 5705.19, .191, .192, .194, .21, .26**

The Village Council of the Village of Bolivar, Tuscarawas County, Ohio, met in regular session on the 1st day of August, 2022, at the office of the Village Hall, with the following members present:

Member Tedd Findlayson moved the adoption of the following Ordinance:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Bolivar, Tuscarawas County, Ohio; therefore, be it

BE IT ORDAINED, By the Village Council of the Village of Bolivar, Tuscarawas County, Ohio two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Bolivar, Tuscarawas County, Ohio, for the purposes of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, or the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.33 of the Revised Code, or the payment of the costs incurred by the village as a result of contracts made with other political subdivisions in order to obtain police protection, or the provision of ambulance or emergency medical services operated by a police department,

BE IT ORDAINED, pursuant to section 5705.19(J) of the Revised Code, a replacement of 2 mills of an existing levy and an increase of 2 mills to constitute a tax at a rate not to exceed 4 mills for each one dollar of valuation, which amounts to \$0.40 for each one hundred dollars in valuation, for continuous years, commencing in 2022, first due in calendar year 2023.

BE IT ORDAINED, That the question of levying a replacement and increase of taxes be submitted to the electors of said Village of Bolivar at the general election to be held at the

usual voting place within said Village of Bolivar on the 8th day of November, 2022; and be it further

BE IT ORDAINED, That said levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if the majority of the electors voting thereon vote in favor thereof; and be it further

BE IT ORDAINED, That the Fiscal Officer of the Village of Bolivar be and is hereby directed to certify a copy of this resolution to the Board of Elections of Tuscarawas County Ohio, ninety (90) days prior to the election upon which it will be voted, and to notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.


