WHEREAS, the Appalachian Community Grant Program, created by House Bill 377, provides support to political subdivisions, educational institutions, port authorities, community improvement corporations, and nonprofits within the 32-county Ohio Appalachian region to undertake projects related to downtown revitalization/Infrastructure, workforce development, and healthcare; and

WHEREAS, OMEGA is the designated Local Development District for Belmont, Carroll, Columbiana, Coshocton, Guernsey, Harrison, Holmes, Jefferson, Muskingum, and Tuscarawas counties, as recognized by the Ohio Governor's Office of Appalachia and the Appalachian Regional Commission; and

WHEREAS, the Appalachian Community Grant Program guidelines encourage applicants to work with their Local Development District to complete their applications for eligible project funding; and

WHEREAS, OMEGA will serve as the lead applicant for the Tuscarawas County Technical Assistance Grant Application for the Appalachian Community Grant Program; and

WHEREAS, the Village of Bolivar requests planning assistance as a vital component of the county-wide vision of inter-connected projects to be presented within an Appalachian Community Grant technical assistance application; and

WHEREAS, the Village of Bolivar is requesting planning and assistance for paving and lighting of the Trailhead located at Canal Street Rear.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

- SECTION 1. That the Village of Bolivar authorizes OMEGA to serve as the lead applicant for a technical assistance grant from the Appalachian Community Grant program on behalf of the communities and non-profit organizations in Tuscarawas County.
