

# Village of Bolivar, Ohio

Ordinance Number: 0-10-2023

**TITLE: AN ORDINANCE TO AUTHORIZE THE HIRING OF MATT JUDY AS ASSISTANT FISCAL OFFICER ON A PART-TIME BASIS; AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village Council of the Village of Bolivar, Ohio, has identified a need for a part-time assistant fiscal officer; and

**WHEREAS**, Matt Judy has expressed an interest in taking a part-time position with the Village as a part-time assistant fiscal officer; and

**WHEREAS**, The Village Council desires to hire Matt Judy as a part-time assistant fiscal officer to work no more than fifteen (15) hours per week and be compensated at the hourly rate of pay of twenty dollars (\$20.00); and

**WHEREAS**, in his capacity as a part-time assistant fiscal officer, Matt Judy shall be entitled to any benefits or other terms of employment as required by law or offered to part-time employees of the Village of Bolivar.

**NOW THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

**SECTION 1.** The Village Council for the Village of Bolivar hereby approves the hiring of Matt Judy as a part-time assistant fiscal officer.

**SECTION 2.** As a part-time assistant fiscal officer, Matt Judy shall work no more than fifteen (15) hours per week and shall be compensated at the regular hourly rate of twenty dollars (\$20.00) per hour.

**SECTION 3.** As a part-time assistant fiscal officer, Matt Judy shall be entitled to any benefits or other terms of employment as required by law or offered to part-time employees of the Village of Bolivar.

**SECTION 4.** This Ordinance repeals all previous Ordinances or parts thereof in conflict herewith.

SECTION 5. It is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that the Village is in immediate need of an assistant fiscal officer; and, this Ordinance shall be in full force and effective immediately upon its passage.
