Ordinance Number: 0-22-2023

TITLE: AN ORDINANCE AUTHORIZING AMENDED AND SUPPLEMENTAL PERMANENT APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF BOLIVAR, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2023; AND DECLARING AN EMERGENCY.

WHEREAS, on November 16, 2023, Council of the Village of Bolivar, State of Ohio adopted an Ordinance Authorizing Permanent Appropriations for Current Expenses and other Expenditures of the Village of Bolivar, State of Ohio, During the Fiscal Year Ending December 31, 2023; and

WHEREAS, this Ordinance is necessary to ensure that sufficient funds are properly appropriated to each fund.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Bolivar, County of Tuscarawas, State of Ohio, that, Ordinance No. 0-4-2023 (establishing the permanent appropriations for expenses during fiscal year 2023) is amended and supplemented to provide for the current expenses and other expenditures of said Village of Bolivar during the fiscal year ending December 31, 2023, the permanent appropriation are amended and supplemented by modifying from one account to another as follows:

BE IT FURTHER ORDAINED that this Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that appropriations must be expeditiously adjusted to meet limits of available funds; and, this Ordinance shall be in full force and effective immediately upon its passage.
