

# Village of Bolivar, Ohio

Ordinance Number: 0-23-2023

**TITLE: AN ORDINANCE TO AUTHORIZE THE HIRING OF BARB KLINE ON A PART-TIME, SEASONAL BASIS; AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village Council of the Village of Bolivar, Ohio, has identified a need for a part-time, seasonal worker to consult with regard to the Fiscal Officer role; and

**WHEREAS**, Barb Kline has expressed an interest in taking a part-time, seasonal position with the Village; and

**WHEREAS**, the Village Council desires to hire Barb Kline as a part-time, seasonal worker to a maximum of 120 hours of a period between November 21, 2023 and December 31, 2023 and be compensated at the hourly rate of pay of \$20.00 per hour; and

**WHEREAS**, in her capacity as a part-time seasonal worker, Barb Kline shall be entitled to any benefits or other terms of employment as required by law or offered to part-time, seasonal employees of the Village of Bolivar.

**NOW THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. The Village Council for the Village of Bolivar hereby approves the hiring of Barb Kline as a part-time seasonal worker effective November 21, 2023.

SECTION 2. As a part-time, seasonal worker, Barb Kline shall work no more than a total of 120 hours, not to exceed 30 total hours in any one workweek, between November 21, 2023 and December 31, 2023, as determined and directed by her supervisor, and shall be compensated at the regular hourly rate of \$20.00 per hour.

SECTION 3. As a part-time, seasonal worker, Barb Kline shall be entitled to any benefits or other terms of employment as required by law or offered to part-time employees of the Village of Bolivar.

SECTION 4. This Ordinance repeals all previous Ordinances or parts thereof in conflict herewith.

SECTION 5. It is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that the Village is in immediate need of a part-time, seasonal worker; and, this Ordinance shall be in full force and effective immediately upon its passage.
