**TITLE: AN ORDINANCE TO ESTABLISH THE HOURLY PAY RATE CAPS/MAXIMUMS AND MINIMUMS FOR EMPLOYEES OF THE VILLAGE OF BOLIVAR**

**WHEREAS**, the Legislative Authority for the Village of Bolivar desires establish hourly pay rate caps and minimums for employees of the Village of Bolivar; and

**WHEREAS**, this Legislation shall repeal and replace Ordinance 098-2014 and Ordinance O-27-2020.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:**

**SECTION 1.** The hourly pay rate caps and minimums for the positions below shall be fixed at the minimum and maximum (or “cap”) amounts set forth as follows:

Position	Minimum	Cap
Street Superintendent	\$20.00/hour	\$26.00/hour
Police Chief	\$20.00/hour	\$26.00/hour
Fiscal Officer	\$20.00/hour	\$26.00/hour
Full Time Sergeant	\$18.00/hour	\$24.00/hour
Full Time Patrolman	\$17.00/hour	\$22.00/hour
Part Time Patrolman	\$16.00/hour	\$20.00/hour
Income Tax Clerk	\$16.00/hour	\$22.00/hour
Assistant Clerk	\$15.00/hour	\$20.00/hour
Seasonal Street Laborer*	\$14.00/hour	\$18.00/hour

\*The combined title “Seasonal Street Laborer” replaces the formerly separate positions of “Street Labor” and “Seasonal Laborer” titles.

**SECTION 2.** All provisions of ordinances and resolutions, including Ordinance 098-2014 and Ordinance O-27-2020, in conflict with the provisions and terms of this Ordinance and exhibits attached hereto, if any, shall be and are hereby repealed.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
