

# Village of Bolivar, Ohio

Ordinance Number: 0-33-2023

**TITLE: AN ORDINANCE TO AUTHORIZE THE HIRING OF PATTY SMITH AS ASSISTANT FISCAL OFFICER FOR THE VILLAGE OF BOLIVAR; AND DECLARING AN EMERGENCY**

WHEREAS, the Legislative Authority for the Village of Bolivar desires to fill the position of Assistant Fiscal Officer for the Village of Bolivar; and

WHEREAS, Patty Smith has expressed a willingness and desire to be appointed to the position of Assistant Fiscal Officer for the Village of Bolivar; and

WHEREAS, the Legislative Authority for the Village of Bolivar desires to hire Patty Smith to serve as Assistant Fiscal Officer for the Village of Bolivar; and

WHEREAS, in her capacity as a Assistant Fiscal Officer, Patty Smith shall be entitled to any pay and benefits or other terms of employment as required by law or offered to full-time employees of the Village of Bolivar, or as otherwise available to the appointed position of Assistant Fiscal Officer for the Village of Bolivar.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. The Village Council for the Village of Bolivar hereby approves the hiring of Patty Smith as Assistant Fiscal Officer for the Village of Bolivar effective immediately.

SECTION 2. As a full-time, hourly non-exempt Assistant Fiscal Officer, Patty Smith shall work between 32 and 40 hours per week, and shall be compensated at the regular hourly rate of twenty dollars (\$20.00) per hour.

SECTION 3. As full-time Assistant Fiscal Officer, Patty Smith shall be entitled to any benefits or other terms of employment as required by law or offered to full-time employees of the Village of Bolivar.

SECTION 4. Unless otherwise approved in writing by the Mayor of the Village of Bolivar, Patty Smith may not work in excess of forty (40) hours in any single work-week.

SECTION 5. This Ordinance repeals all previous Ordinances or parts thereof in conflict herewith.

SECTION 6. It is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 7. This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that the Village is in immediate need of an Assistant Fiscal Officer; and, this Ordinance shall be in full force and effective immediately upon its passage.
