Ordinance Number: 0-8-2023

TITLE: AN ORDINANCE CORRECTING NUMBERING ERRORS CONTAIN WITHIN CERTAIN LEGISLATION ADOPTED IN CALENDAR YEAR 2022; AND DECLARING THE SAME TO BE AN EMERGENCY

WHEREAS, the Fiscal Officer for the Village of Bolivar has identified certain numbering errors with resolutions and/or ordinances adopted by the Legislative Authority for the Village of Bolivar in calendar year 2022; and

WHEREAS, the Legislative Authority for the Village of Bolivar desires to correct these numbering errors to ensure clarity in the books and records of the Village of Bolivar.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. The numbering system that is in place requires sequential numbering for each separate ordinance and each separate resolution.

SECTION 2. The following pieces of legislation duly passed and authorized by the Legislative Authority are hereby amended and renumbered as follows:

That it is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in

meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5. This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that it is necessary to ensure clarity in the legislation adopted by the Village of Bolivar; and, this Ordinance shall be in full force and effective immediately upon its passage.
