

# Village of Bolivar, Ohio

Resolution Number: R-20-2023

**TITLE: A RESOLUTION TO MAKE TEMPORARY APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF BOLIVAR AS PROVIDED BY REVISED CODE SECTION 5705.38; AND DECLARING THE SAME TO BE AN EMERGENCY**

WHEREAS, the Legislative Authority for the Village of Bolivar is empowered by the Ohio Constitution and R.C. 5705.38 to make temporary appropriations for current expenses and other expenditures of the Village.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

SECTION 1. That the passage of the annual appropriation measure is hereby postponed.

SECTION 2. To provide for the current expenses and other expenditures of the Village of Bolivar, Village Council hereby adopts and passes the following temporary appropriation measure for meeting ordinary expenses of the Village until no later than the first day of April 2024:
