

# Village of Bolivar, Ohio

Resolution Number: R-3-2023

**TITLE: A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO AMEND THE CERTIFICATE OF ESTIMATED RESOURCES FOR THE YEAR 2023; AND DECLARING AN EMERGENCY**

**WHEREAS**, Council approved certain items within the provisions of said budget; and

**WHEREAS**, Council did on the 2<sup>nd</sup> day of February 2023, approve, by motion, the following adjustment in Certificate of Estimated Resources per Exhibit "A" effective \_\_February 2<sup>nd</sup> \_\_, 2023.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, AND STATE OF OHIO, AS FOLLOWS:**

Section 1. That, effective the 2<sup>nd</sup> day of February 2023, the Fiscal Officer of the Village is hereby authorized, directed and approved to take all necessary steps to amend the Certificate of Estimated Resources for the year 2023.

Section 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Resolution is hereby declared to be and is passed as an emergency measure, the emergency being the need to continually provide for the fair and prudent administration of Village affairs. Said resolution is necessary for the immediate preservation of the public, peace, health, safety, and welfare of the inhabitants of the Village of Bolivar.
