BE IT FURTHER ORDAINED that this Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, safety, and general welfare for the reason that appropriations are required to be enacted on or before April 1, 2024; and, this Ordinance shall be in full force and effective immediately upon its passage.
