## TITLE: A RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE AND REMOVAL OF ON-STREET PARKING FOR SPECIAL EVENTS

**WHEREAS**, the Village Council of the Village of Bolivar, Ohio possesses the authority to close portions of streets for celebrations and local special events, when, in the opinion of the Village Council, the closing is necessary for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

**WHEREAS**, the Village Council has identified the following special events for year 2022:

Strawberry Festival – June 5-8, 2024; Canal Street Cruise-In Car Show – July 20, 2024; and Christmas on the Canal – November 9, 2024.

**NOW THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BOLIVAR, COUNTY OF TUSCARAWAS, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

- <u>SECTION 1.</u> The following temporary street closures are necessary to maintain the safety and protection of patrons to these events:
  - Canal Street from Sandy Street up thru Pine Street
  - Sassafras Alley from Sandy Street up thru Pine Street
  - All of the following streets between Canal Street and Sassafras Alley: Sandy Street, Tuscarawas Street, Water Street, Cherry Street, Poplar Street and Pine Street
- SECTION 2. These temporary street closures for the Strawberry Festival shall be in effect from June 5, 2024 at 8:00 am until 12:00 p.m. on June 8, 2024.
- SECTION 3. The specific date and time of temporary street closures for the Canal Street Cruise-In Car Show and Christmas on the Canal will be selected at a later date but will be determined based on the necessary safety and protection of the patrons.
- <u>SECTION 4.</u> This Resolution repeals all previous Ordinances or Resolutions or parts thereof in conflict herewith.
- SECTION 5. It is found and determined that all formal actions of this Council concerning and related to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
